The third party may not be required to abide by this Authorization or applicable federal and state law governing the use and disclosure of my health information. I understand that this authorization will remain in effect until the term of this authorization expires or I provide a written notice of revocation to my health care provider. The revocation will be effective immediately upon my health care provider's receipt of my written notice. Immunization CLAIMS

Completed Immunization Form (one time, unless information has changed)
Copy of the patient's insurance cards

A copy of **ALL** Medicare/Medicaid/Insurance Remittance Advices (EOB's), (Primary and Secondary), should be forwarded to E.B.S. to ensure proper payment was made, and to update your accounts receivable. In some cases, EBS will download these remittances electronically and forward to you a copy (via email or fax). Clients failing to forward necessary EOB's/remittance advices to EBS will be subject to a rate increase of EBS fees.

All correspondence (requests for additional information, audits, recoupment's, etc) from insurance, Medicare, Medicaid, etc must be forward to EBS promptly. These documents generally have time limits for response.

Each month you will receive a Patient Statement for any amount owed to you by your patient. A copy of all Patient Payments must be sent to EBS to ensure that their account is properly credited.

You can receive an account summary report indicating the aging of balances, monthly billing journal and cash receipts journal, and a held orders report by logging into HDMS Mobile Reporting.
